1. The exhibition will be held in Bjelovar **between 12<sup>th</sup> June and 3<sup>rd</sup> July, 2015**

3. The Exhibition jury will select the photographs for the exhibition.
4. The Exhibition jury will proclaim the Grand Prix of the Salon, 3 individual photographs and 3 best photo-series and select the photo for the poster of the Salon.
5. The Exhibition jury will award up to three acknowledgments for individual photographs and up to three photographs for photography series.
6. The winner of the Grand Prix became the President of the Jury of the next Salon and is entitled to a solo exhibition in place and time of the next salon.
7. All decisions of the Exhibition Jury are final and irrevocable.
8. Every author will receive a copy of the Exhibition Catalogue to the address in the application forms.

### Competition rules:

- a) The motif should be within the prescribed topic «Forest in Forester's Eye»;
- b) All members of the Croatian Forestry Society including both the active and retired staff, the employees of «Croatian Forests» («Hrvatske šume»), as well as all interested foresters from the country and abroad have the right of participation;
- c) Please demand the application form from the organiser and fill in your personal data and the photography data in the enclosed application form
- d) Every author can apply to the Competition with up to 10 individual photographs and up to 2 series with 3-6 photographs; one series is considered one single photograph;
- e) The photographs should be unequipped, the longer sides should not be shorter than 24 cm, or longer than 30 cm. For the sake of anonymity, the backsides of the photographs should contain only the title and the order number of the application form; if you have your own digital record on a transferable media, please enclose it;
- f) The organiser has the right of organising the exhibition in other places of the Republic of Croatia during the next two years after the first exposure and is committed to following the last exposure photos back to author;
- g) Every author is personally responsible for the presented motif; every author also permits the reproduction and publication of his/her photography in the publications of HŠD and other media and publications for the purpose of promoting the Salon, unless the authors explicitly forbid it.
